

Monterey Bay Great Dane Club General Meeting

Dail and Diane are continuing to work on acquiring the approval for having a raffle at the designated specialties at Woofstock in June. Laura agreed to send the judges contracts to Diane. Judges are making their own hotel reservations. Kate reported that shirts are currently not being ordered for the show. Laura reported that so far, Denise has raised approximately \$4,000 for trophy donations for the GDCNC and \$1,800 for the MBGDC. Laura needs help with Judges Hospitality. Kate will be doing morning hospitality and stated that the tables and canopy will be left up for Mary and Gail to use for the luncheon that they will be serving.
